Attention Contractors, Builders, & Subcontractors working in Victorville

Only the City's franchised hauler, Victorville Disposal (Burrtec), is permitted to haul solid waste in the City of Victorville.

Per VMC 6.36.040 (a), "Waste generators" (or their employees) are permitted to self-haul waste but only if the waste is transported utilizing equipment owned and/or leased by the waste generator. Trade subcontractors (drywall, framers, HVAC, painters, plumbing, electrical, etc.) would be considered waste generators and may remove waste generated from their activities. However, per VMC 6.36.010, under the definition of Waste Generator, "A contractor or subcontractor engaged for the purpose of collecting, hauling, and transporting waste is not a waste generator." Therefore, it is not permissible to subcontract waste removal to a company other than the city's franchised hauler, Victorville Disposal.

Job Site "Cleanup Contractors" Information

It is common for builders to hire "cleanup contractors" to keep construction job sites free of trash. It is permitted to use cleanup contractors for the purpose of cleaning job sites; <a href="https://www.newver.gov/howeve

Notice: Exclusive Solid Waste Hauling Franchise and 65% Diversion Requirement

<u>Solid Waste Services Must Be Provided by the City's Franchised Hauler—Victorville Disposal</u>

Only the City's franchised hauler, Victorville Disposal (Burrtec), is permitted to haul solid waste in the city. Solid waste hauling is a franchised operation in the City of Victorville. Per Victorville Municipal Code Section 6.36.040, "The city and its duly authorized agents, servants, and employees or the City Waste Handling Contractor...shall have the exclusive right to provide solid waste handling services from all Premises in the City; and no person other than those above specified shall provide solid waste handling services, convey or transport any solid waste material in, along or over any public street...."

Per VMC 6.36.040 (a), "Waste generators" (or their employees) are permitted to self-haul waste but only <u>if the waste is transported utilizing equipment owned and/or leased by the waste generator</u>. Trade subcontractors (drywall, framers, HVAC, painters, plumbing, electrical, etc.) would be considered waste generators and may remove waste generated from their activities. <u>However, per VMC 6.36.010</u>, under the definition of Waste <u>Generator</u>, "A contractor or subcontractor engaged for the purpose of collecting, hauling, and transporting waste <u>is not a waste generator</u>." Therefore, it is not permissible to subcontract waste removal to a company other than the city's franchised hauler, Victorville Disposal.

Job Site "Cleanup Contractors" Information

65% Diversion Requirement Notice

CalGreen and Victorville Municipal Code Title 16, Chapter 5, Article 11 require all building permit applicants to submit a Construction Waste Management Plan (CWMP). The CWMP outlines how the applicant will divert a minimum of 65% of non-hazardous construction waste from the landfill.

The City's franchised waste hauler, Victorville Disposal (Burrtec) can provide roll-offs for mixed construction/demolition materials. The material will be hauled to a mixed material processing facility. Material is sorted and recovered, with a guaranteed minimum diversion rate of 65% for all loads processed, ensuring full compliance with CalGreen and City of Victorville Municipal Code diversion requirements.

When arranging for mixed waste roll-off service, please make sure to notify the Victorville Disposal customer service representative that you need to have the loads go to mixed waste processing and that they must comply with the 65% diversion requirement of CalGreen.

Additional Information & Resources For Construction and Demolition Recycling

<u>65% Diversion Guaranteed By Using City-Franchised Hauler:</u> The City's franchised waste hauler, Victorville Disposal (Burrtec) can provide roll-offs for mixed construction/demolition materials. The material will be hauled to a mixed construction waste processing facility where it is sorted into different categories and recovered, with a guaranteed minimum diversion rate of 65% for all loads processed. This option ensures full compliance with CalGreen and City of Victorville Municipal Code diversion requirements.

Starting Trash/Recycling Service For Your Construction Project: Contact Victorville Disposal at 760-245-8607 to start service. When arranging for mixed waste roll-off service, make sure to notify the Victorville Disposal customer service representative that this is for a construction project and you need to have the loads go to mixed waste processing and that they must comply with the 65% diversion requirement of CalGreen.

<u>Scheduling Service on Your Roll-offs:</u> Most bins are on regular service, however if you need to call in for service, call Victorville Disposal at 760-245-8607. Make sure to remind the customer service representative that the load needs to be directed to the construction recycling facility for the 65% diversion.

<u>Project Documentation—Tonnage Reports:</u> Before your final inspection, you will need to provide the City with documentation to prove that at least 65% of project debris was recycled. <u>Victorville Disposal (Burrtec) can provide you with a "Tonnage Detail" report that lists the loads that were hauled, dates, tonnage, where the loads were taken, and diversion amounts.</u> It is recommended that you request these reports monthly, to monitor your project progress and ensure that loads are being hauled to the appropriate facility(s).

<u>Concrete and Asphalt:</u> Even if you use a roll-off for mixed construction materials, <u>it is highly recommended</u> <u>that your project source separate concrete and asphalt whenever possible.</u> Disposal fees for clean concrete and asphalt loads are significantly lower than fees for mixed waste processing, because these loads can be hauled directly to a concrete/asphalt recycler. The City's franchised hauler Victorville Disposal (Burrtec) can provide concrete washout containers and "low-boy" (10 cubic yard) roll-offs for asphalt materials. Note: Your concrete trade subcontractor may also be able to supply concrete washout containers.

<u>Universal Wastes Require Separate Handling:</u> Hazardous and toxic tems such as fluorescent lights, batteries, lighting ballasts, mercury containing thermostats, electronics, TV's, etc. are considered Universal Waste and cannot be discarded with trash. These items require special handling. Call the City of Victorville Environmental Programs Division at 760-245-8607 if you need assistance with managing Universal Waste materials from your project.

<u>Guide To Construction and Demolition Recycling Facilities:</u> The City of Victorville Environmental Programs Division has put together a "Construction & Demolition Recycling Guide for the Victor Valley." This 24-page guide lists places where you can recycle concrete, asphalt, dirt, wood, carpet, green waste (brush), scrap metal, and more. It also includes information on the Victorville Landfill, free paint recycling program, and Universal Waste requirements. Call 760-955-8615 to request a copy.
