



**AMENDMENT NO. 2 TO THE  
FIRST AMENDED, CONSOLIDATED AND RESTATED EXCLUSIVE  
FRANCHISE AGREEMENT BETWEEN THE CITY OF VICTORVILLE,  
CALIFORNIA AND VICTORVILLE DISPOSAL, INC.**

This Amendment No. 2 to the First Amended, Consolidated and Restated Exclusive Franchise Agreement for Solid Waste Refuse and Waste Diversion (Recycling) Services (“Amendment No. 2”), dated June 26, 2018 for reference purposes only, is entered into by and between the City of Victorville (“City”), a charter city and municipal corporation organized under the laws of the State of California and VICTORVILLE DISPOSAL, INC., a California corporation (“Contractor”). City and Contractor are sometimes hereinafter individually referred to as a “Party” and collectively referred to as the “Parties.”

**RECITALS**

**WHEREAS**, in November 2009, City and Contractor entered into, and the City Council adopted, the First Amended, Consolidated and Restated Exclusive Franchise Agreement for Solid Waste Refuse and Waste Diversion (Recycling) Services (the “Current Franchise Agreement”) for the purposes of providing reliable and cost-effective solid waste handling and recycling services to residents and business in the City; and

**WHEREAS**, in August 2014 the City Council approved, and in September 2014, the City and Contractor entered into, Amendment No. 1 for the purposes of providing reliable and cost-effective staffing services for the City’s Household Hazardous Waste Collection Center; and

**WHEREAS**, California Public Resources Code section 40059 *et seq.*, authorizes the City to determine and arrange for all aspects of solid waste handling; and

**WHEREAS**, on June 5, 2018, the City Council adopted Resolution No. 18-012 establishing a schedule of periodic fees and frequency of collection for the collection and disposal of solid waste and recyclables materials, recyclable material processing, and management of household hazardous wastes; and

**WHEREAS**, City and Contractor wish to amend the Current Franchise Agreement so that it is consistent with the fee structure adopted in Resolution No. 18-012.

**NOW, THEREFORE**, in consideration of mutual covenants and conditions contained and made in this Amendment No. 2, the Parties hereto agree as follows:

- A. Article 8. “FRANCHISE FEES AND ADMINISTRATIVE FEES” is hereby amended to read as follows:**

## **ARTICLE 8. FRANCHISE AND OTHER FEES**

### **8.01 GENERAL**

- A. Franchise Fees. In consideration for the rights and privileges provided in this Agreement, and the costs associated in providing services thereunder, the City will retain Franchise Fees from the sums collected from its Customers for such services. The Franchise Fee is set at eight percent (8%) of the sum of the Administrative, Pavement Impact, AB 939 Recycling, Mandatory Commercial Organics, Collection, and Disposal Rate Components. Contractor shall pay to the City a Franchise Fee in the same amount provided in this paragraph for all sums collected directly from its temporary Customers within the City under this Agreement.
- B. Other Fees Comprising the Rate. The City shall retain other components comprising the rate, which include Administrative, Pavement Impact, AB 939 Recycling, Mandatory Commercial Organics, and Disposal Fees collected from its Customers. Contractor shall pay to the City the Pavement Impact and AB 939 Recycling Fees in the same amounts as billed by City to permanent City customers for all sums collected directly by Contractor from Contractor's temporary Customers under this Agreement.

**B. Article 10.06. "ANNUAL FORMULA-BASED COMPENSATION ADJUSTMENT" is hereby amended to read as follows:**

### **10.06 ANNUAL FORMULA-BASED COMPENSATION ADJUSTMENT**

Contractor's Compensation. Contractor's compensation as set forth in Attachment E, Contractor Service Unit Rates, shall be adjusted each July 1<sup>st</sup> by an amount equal to the average January to January change in the Consumer Price Index for All Urban Consumers for Riverside-San Bernardino-Ontario as published by the United States Department of Labor, Bureau of Labor Statistics ("CPI"). Accordingly, the first such adjustment shall become effective July 1<sup>st</sup>, 2019, and shall be based on the average change from January 2018 to January 2019.

- a. Adjustment Request Procedure. Contractor shall submit its request for a CPI-based rate adjustment not later than April 5<sup>th</sup> of each year using the form specified in Attachment E, accompanied by a complete revised proposed Attachment E, Contractor Service Unit Rates, reflecting the CPI-based rate adjustment.
- b. Adjustment Approval Procedure. Contractor's request shall be reviewed and approved by the City Manager or designee. The City Manager's decision shall be based solely upon verification of the change in CPI in accordance with the formula set forth in this Agreement and verification of Contractor's computations of the changes in Attachment E, Contractor

Service Unit Rates. The City Manager's approval shall be rendered not later than June 15<sup>th</sup> and shall not be unreasonably withheld.

**C. Attachment A, "DEFINITIONS" shall be amended to read as follows:**

**ATTACHMENT A**

**DEFINITIONS**

Unless the context otherwise requires, capitalized terms used in this Agreement shall have the meanings set forth below.

- a. AB 939 Recycling Fee/Rate Component – The term "AB 939 Recycling Fee" or "AB 939 Rate Component" shall mean a component of the total rate charged to the Customer for solid waste and recycling services to cover the costs associated with the City's efforts to comply with California State Assembly Bill 939 and subsequent additional State mandated diversion programs.
- b. Administrative Fee/Rate Component – The term "Administrative Fee" or "Administrative Rate Component" shall mean a component of the total rate charged to the Customer for solid waste and recycling services to cover the cost for City administration of solid waste and recycling programs, as well as customer service and billing functions.
- c. Agreement – The term "Agreement" shall mean this contract, entered into between City and Contractor
- d. Bin Service – The term "Bin Service" shall mean collection service pursuant to an agreement between the Contractor and his customers by which bin containers (dumpsters) are rented to the customers.
- e. Bulky Waste – The term "Bulky Waste" shall mean large items of Solid Waste such as appliances, furniture, large auto parts, trees, branches greater than 4 inches in diameter and 36 inches in length, stumps and other oversize wastes whose large size precludes or complicates their handling by normal collection, processing or disposal methods.
- f. City – The term "City" shall mean the City of Victorville.
- g. City Council – The term "City Council" shall mean the City Council of the City of Victorville.
- h. City Manager – The term "City Manager" shall mean the City Manager of the City of Victorville.
- i. Code – The term "Code" shall mean the Municipal Code of the City of Victorville, both codified and miscellaneous ordinances.

- j. Collection Fee/Rate Component – The term “Collection Fee” or “Collection Rate Component” shall mean a component of the total rate charged to the Customer for solid waste and recycling services to cover the costs due to Contractor per Attachment E, Contractor Service Unit Rates.
- k. Collection Service – The term “Collection Service” shall mean all or any part of the activities involved in collecting and transporting solid waste, recyclable materials or green waste to an appropriate disposal or recycling facility.
- l. Commercial/Industrial Premises – The term “Commercial/Industrial Premises” shall mean stores, offices, including manufacturing and industrial offices and facilities, restaurants, warehouses, schools, colleges, universities, hospitals, and other non-manufacturing entities.
- m. Commercial Recycling Program – The term “Commercial Recycling Program” shall mean Source Separated Commercial Recycling and Select Commercial Recycling
- n. Compost – The term “Compost” shall mean controlled biological decomposition of organic material, producing a stable soil amendment.
- o. Construction and Demolition Waste – The term “Construction and Demolition Waste” shall mean used or discarded construction materials removed from a premise during construction, demolition or renovation of a structure where a City permit has been issued.
- p. Customer – The term “Customer” shall mean those generators of solid waste, recyclable materials or green waste to whom a franchisee provides collection service.
- q. Disposal Facility – The term “Disposal Facility” shall mean any dump site, transfer station or other place specifically designed for the receipt and disposition of refuse collected by Contractor pursuant to this agreement.
- r. Disposal Fee/Rate Component – The term “Disposal Fee” or “Disposal Rate Component” shall mean a component of the total rate charged to the Customer for solid waste and recycling services to cover the cost to dispose of residential and commercial waste and residue from the Victor Valley Materials Recovery Facility processing center as collected by the Contractor and disposed at the San Bernardino County landfill.
- s. Exclusive Solid Waste Handling Services – The term “Exclusive Solid Waste Handling Services” means any action by the City, whether by franchise, contract, license, permit, or otherwise, whereby the City itself or one or more other local agencies or solid waste enterprises has the exclusive right to provide solid waste handling services of any class or type within all or any part of the territory of the local agency.
- t. Franchise – The term “Franchise” shall mean a certificate, contract, or license issued by the City authorizing a person to provide solid waste and recycling collection service and to use City streets.

- u. Franchisee – The term “Franchisee” shall mean the person granted the exclusive franchise by this Agreement.
- v. Gate Fee – The term “Gate Fee” shall mean the fee charged for the disposal of solid waste at any public or private landfill, transfer station and/or resource recovery or recycling facilities.
- w. Green Waste – The term “Green Waste” shall mean compostable materials including grass clippings, leaves, pruning and similar vegetative materials; but does not include sod, stumps, or similar bulky materials, rocks or dirt.
- x. Mandatory Commercial Organics Fee/Rate Component – The term “Mandatory Commercial Organics Fee” or “Mandatory Commercial Organics Rate Component” shall mean a component of the total rate charged to the Customer for solid waste and recycling services to cover the cost associated with the City’s efforts to comply with California State Assembly Bill 1826.
- y. Multi-Family Premises – The term “Multi-Family Premises” shall mean any building or group of buildings that contain 5 or more dwellings.
- z. Organic Material – The term “Organic Material” shall mean materials that can be biologically synthesized by plants or animals from simpler substances, are no longer suited for their intended purpose, and are readily broken down by biological processes into soil constituents. Examples include, but are not limited to, food waste, green waste, paper, and putrescible material which are generally a source of food for bacteria.
- aa. Non-Residential Premises – The term “Non-Residential Premises” shall mean Commercial/Industrial and Multi-Family Premises.
- bb. Pavement Impact Fee/Rate Component – The term “Pavement Impact Fee” or “Pavement Impact Rate Component” shall mean a component of the total rate charged to the Customer for solid waste and recycling services to recover a portion of the costs of street repair that is directly related to the impacts of collection vehicles on City streets.
- cc. Processing Facility – The term “Processing Facility” shall mean a facility designated by the City to accept recycling material for the purpose of reduction, separation, recovery and conversion.
- dd. Rate Component – The term “Rate Component” shall mean any individual fee comprising the total rate charged to the Customer, which include the Administrative, Pavement Impact, AB 939 Recycling, Mandatory Commercial Organics, Disposal, Collection, or Franchise Fee.
- ee. Recyclable Materials – The term “Recyclable Materials” shall mean Solid Waste that is source separated, has some potential economic value, and is set aside, handled, packaged, or offered for collection in a manner different from Refuse in order to allow it to be processed for recycling. Recycling Materials must be acceptable to the Processing Facility, and include paper, cardboard, glass, metal, and rigid plastic containers.

- ff. Refuse – The term “Refuse” shall mean Solid Waste, as defined herein. However, the term “Refuse”, for purposes of this Agreement, shall not be deemed to refer to or include dead animals, manure, sewage waste or waste water, explosive substances, radioactive materials, materials which have been exposed to highly infectious or contagious diseases, or other hazardous materials.
- gg. Residential Premises – The term “Residential Premises” shall mean a single family dwelling or a multi-family dwelling with up to and including 4 dwelling units on a single tax lot.
- hh. Select Commercial Recycling – The term “Select Commercial Recycling” shall mean the collection of non-residential bins that include high concentrations of Recyclable Materials, as evidenced by the Customers’ typical generation, but that are not otherwise collected as Commercial Recycling.
- ii. Service Unit – The term “Service Unit” shall mean each of the following which receives standard service: each single-family dwelling, each dwelling unit within a duplex, triplex or multi-family residential building, each apartment or condominium unit within an apartment or condominium building, and each business, professional, industrial or other non-residential use unit.
- jj. Solid Waste – The term “Solid Waste” shall mean all putrescible and nonputrescible solid and semisolid wastes, including garbage, trash, refuse, paper, rubbish, ashes, industrial wastes, demolition and construction wastes, discarded home and industrial appliances, manure, vegetable or animal solid and semisolid wastes, and other discarded solid and semisolid wastes. “Solid Waste” does not include hazardous waste as defined by the State of California, or low-level radioactive waste. “Solid Waste” does not include medical waste which has not been treated for disposal at a solid waste facility.
- kk. Solid Waste Handling Services – The term “Solid Waste Handling Services” shall mean the collection, transportation, storage, and transfer of solid wastes for residential, commercial, institutional, or industrial users or customers.
- ll. Source Separated Commercial Recycling – The term “Source Separated Commercial Recycling” shall mean the collection of bins that have high concentrations of source separated Recyclable Materials.
- mm. Standard Service – The term “Standard Service” shall mean curbside collection service required for all service units not arranging with the Contractor for bin service nor required by the City to obtain bin service from the Contractor.
- nn. Waste Generator – The term “Waste Generator” shall mean any Person, including any contractors or subcontractors acting on such Person’s behalf, whose act or process produced Solid Waste, or whose act first causes Solid Waste to become subject to City’s regulatory authority. A contractor or subcontractor engaged for the purpose of collecting, hauling, and transporting waste is not a waste generator.

**D. Attachment B, “SCOPE OF SERVICES” shall be amended to read as follows:**

## **ATTACHMENT B**

### **SCOPE OF SERVICES**

The services to be performed by Contractor are as follows and are subject to change as described in Section 10.08 of this Agreement.

- a. Provide carts for automated collection of residential Solid Waste and Recyclable Materials in accordance with Section 7.03.
- b. Provide fully automated, once a week collection of residential Solid Waste and Recyclable Materials.
- c. Provide each single family residential dwelling up to two Bulky Item collections each twelve month period.
- d. Provide annual residential curbside Christmas Tree Collection.
- e. Provide containers for collection of commercial Solid Waste, Organic Material, and Recyclable Materials in accordance with Section 7.03.
- f. Provide for collection of commercial Solid Waste, Organic Material, and Recyclable Materials up to seven days per week.
- g. Provide for collection of Solid Waste and Recyclable Materials from selected City Facilities in accordance with Subsection 5.01d.
- h. Provide Customer Services in accordance with Section 6.01.
- i. Provide Records and Reports in accordance with Article 11.
- j. Provide a pilot program for Organic Material (Food and Green Waste) residential and commercial Collection and Composting, at Contractor’s sole cost.
- k. Provide a quarterly event for document destruction (Shred-Fest), at Contractor’s sole cost.
- l. Development and management of commercial recycling outreach program.
- m. Implement a program to utilize Radio Frequency Identification Devices on all new residential carts and all existing and new non-residential and residential bins;
- n. Establish a periodic residential and non-residential route audit and service verification program, linked to Customer billing;

- o. Provide a social marketing based program to reduce recycling contamination and increased recyclable material recovery for residential and non-residential customers, including a comprehensive container inspection and compliance element;
  - p. Provide labor and equipment needed to organize two annual community clean-up events, at Contractor's sole cost.
  - q. Provide for the development and management of school outreach recycling programs including annual site visits to all schools and classrooms within the City limits which receive Collection Services provided by Contractor under this Agreement, provided such schools and classrooms continue to receive such Collection Services.

**G. EFFECTIVE DATE, TERM, AND TERMINATION**

1. This Amendment No. 2 shall become effective upon the date this Amendment No. 2 has been: (a) approved as to form by the City Attorney and the City's Risk Manager; (b), fully executed by the Parties; and (c) approved by the City Council (the "Effective Date"). For the purpose of calculating any payments between the Parties, the effective date of the rates in Attachment D and Attachment E, July 1, 2018, shall be observed retroactively. Unless terminated in accordance with the provisions of Section C.2 of the Current Franchise Agreement, this Amendment No. 2 shall remain in effect until further amended in writing by the Parties.
2. Except as specifically set forth in this Amendment No. 2, all terms and provisions of the Current Franchise Agreement, including without limitation, Article 12 relating to indemnity and insurance, shall continue in full force and effect.
3. This Amendment No. 2 may be executed in one or more counterparts, each of which shall be deemed an original, but all of which shall constitute one and the same document.


