NOTICE IS HEREBY GIVEN THAT the Victorville City Council and Board of Directors of the Victorville Water District shall conduct a public hearing on December 19, 2023, at 6:00 p.m. (or as soon thereafter as the matter may be heard) in the Council Chambers of City Hall located at 14343 Civic Drive, Victorville, California, for the purposes of hearing arguments for and against proposed Resolution Nos. 23-100 and VWD 23-015 which propose to approve and adopt the updated Capital Improvement Plan, the updated City Council Policy relating to Development Impact Fee and Capacity Charges, and an updated DIF Master Fee Schedule.
